We're looking forward to counting you as a member of our growing professional group throughout the South. Your membership in the *Southern Early Childhood Association* demonstrates your commitment to your profession and your own personal growth and development.

On **page 2** of this document, you will find a **Membership Dues List** that outlines the dues for each state in the SECA region. Dues vary by state and are set by the state affiliates. Some of our states offer you membership in both the state affiliate and SECA: others offer you membership in the state affiliate, SECA and NAEYC. (This list includes only the state, regional and national membership dues. If you wish to join a local affiliate/chapter as well, call the SECA office at **1-800-305-SECA** and we'll provide you with the information you need to connect with your local affiliate.)

On **page 3** of this document, you will find an **Affiliate Membership Application**. This membership is open to anyone living in the SECA states or those who wish to join a particular state affiliate.

On **page 4** of this document, you will find a **Non-Affiliate Membership Application**. This type of membership is available *ONLY* to persons residing outside of the SECA states. **If you reside in a SECA state and send in a non-affiliate application, it will be returned to you with the appropriate state application form.**

If you are **applying for membership as a CDA candidate or renewal candidate**, SECA will be happy to provide you with a *membership letter* if your membership card will not arrive in time to submit your application. Membership cards are mailed by the 15<sup>th</sup> of the month in which you apply. For example, August membership cards are mailed by September 15<sup>th</sup>. Just let us know that you need a letter, and we'll send it out to you within two working days.

- ❖ The NAEYC portion of the dues in your state is \$25.
- ❖ Some local chapters require the payment of additional dues. For information about whether the local affiliate you want to join requires a fee in addition to those listed above, call the SECA office at 1-800-305-SECA and we'll provide you with that information.

- ❖ Non-affiliate membership is available only to persons living outside the SECA states of Alabama, Arkansas, Florida, Georgia, Kentucky, Louisiana, Mississippi, Oklahoma, South Carolina, Tennessee, Texas, Virginia and West Virginia.
- ❖ Residents of North Carolina are eligible to join as a non-affiliate member.

## Affiliate Membership Application

Affiliate membership is designed especially for persons living inside the states with SECA affiliates. **SECA affiliate states are Alabama, Arkansas, Florida, Georgia, Kentucky, Louisiana, Mississippi, Oklahoma, South Carolina, Tennessee, Texas, Virginia and West Virginia.**

If you join SECA and live in **Arkansas, Louisiana, Mississippi or South Carolina**, that membership includes both the state affiliate and SECA.

If you join SECA and live in **Alabama, Florida, Georgia, Kentucky, Oklahoma, Tennessee, Texas, Virginia or West Virginia**, that membership includes the state affiliate, SECA and NAEYC (National Association for the Education of Young Children.)

**Affiliate dues vary by state** and you can find the affiliate membership dues amount for your state on our Membership Dues List. You can also choose to join your local affiliate as you submit your membership.

### Non-Affiliate Membership Application

Non-affiliate membership is designed especially for persons living outside the states with SECA affiliates. SECA affiliate states are Alabama, Arkansas, Florida, Georgia, Kentucky, Louisiana, Mississippi, Oklahoma, South Carolina, Tennessee, Texas, Virginia and West Virginia. If you live in a state other than those listed as SECA affiliate states, you are eligible to join SECA as a non-affiliate member.

Non-affiliate dues are \$30.00 per year/per person for an individual living in the continental United States (including Alaska and Hawaii) and \$40.00 per year/per person for those persons living outside the United States.
